For use in and around buried cables, cable television pedestals, cables, pad-mounted air conditioning units, pad-mounted electric power transformers, telephone cables, underground vaults, telecommunications equipment (boxes, closures, interfaces, pedestals, protectors and terminals), power and utilities equipment (camera housings, control panels, emergency light systems, fire alarm systems and lights/alarms) and railroad systems equipment (breaker boxes, railroad signals, traffic control boxes and signals, and transformer pads).

RAINBOW INSECT TAG is a self-contained, continuous release insecticide. It kills ants (except Harvester, Pharaoh and Carpenter), bees, crickets, earwigs, hornets, millipedes, silverfish, sowbugs, spiders (including Black Widow and Brown Recluse), wasps and yellow jackets. **Do not open until ready to use.** Open outer package (do not remove tag from holder), secure tag(s) with ties. Due to various equipment sizes, the amount of product may vary, however not more than two tags per three cubic feet is recommended. Use in interior areas at points of entry. Do not place product where it will interfere with moving parts of equipment. Do not place tag on outside of equipment or in exposed locations where direct contact with children, pets, food or clothing is likely to occur. Monitor effectiveness and replace tag(s) when effectiveness diminishes.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal. **Pesticide Storage:** Store unopened in a cool, dry place inaccessible to children and pets. **Pesticide Disposal:** Used tags and wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility. **Container Handling:** Non-refillable container; do not reuse or refill this container.
