WHERE TO USE

FOR OUTDOOR USE ONLY. HOW TO APPLY / USE

1. Turn sprayer nozzle to open. Adjust sprayer nozzle as desired.
2. Spray to thoroughly cover unwanted weeds and grasses or spray to thoroughly cover areas where you want to prevent weed and grass growth.
3. Do not spray ornamental plants or grasses, as damage will occur.
4. When treating around desirable plants, shield plants from drift with a sheet of cardboard or plastic. If desirable plants are accidentally sprayed, rinse off immediately with water.

The preemergent herbicide prodiamine in this product is yellow in color, which allows the user to see the area that has been sprayed. If sprayed on cement curbs, sidewalks, and driveways it may temporarily stain if not washed off immediately after application. Caution should be used not to wash the product off target weeds or weed control may be adversely affected. Treated areas should be dry before entering to avoid staining onto non-treated surfaces.

WHEN TO REPLANT

All ornamental bedding plants, trees, shrubs, sod, and seed (flowers and grasses) may be planted 12 months after application when applied at the 1 quart per 305 sq. ft. use rate or 6 months when applied at the 1 quart per 600 sq. ft. use rate. For longer pre-emergent control and post-emergent control of larger weeds use the higher rate.
